Due to the instability and rising prices of propane gas in international markets and the increase in the CO2 emission fee, Rolegás has been forced to adjust its prices in accordance with the conditions observed, in order to ensure the sustainability and quality of the service provided.

Therefore, starting on November 25, 2024, the prices will be applied according to the following price table:
